

EOPPEP ID


Operational Framework

EOPPEP operates under the supervision of the Minister of Education & Religious Affairs, Culture & Sports and is seated in Athens. It has derived from the amalgamation of three national bodies, all under the supervision of the same Ministry: the National Centre for the Accreditation of Lifelong Learning Providers (EKEPIS), the National Organisation for the Certification of Qualifications (EOPP) & the National Centre for Vocational Guidance (EKEP).

Mission

- **Licensing/Certification of non formal education and III Providers:** Private primary and secondary schools, Colleges (Centres for Post- Lyceum Education), Private Initial VET Institutions, Continuing VET Institutions, other non formal education providers
- **Certification of Occupational Profiles and non formal education curricula**
- **Development of National Qualifications Framework**
- **Development and implementation of an integrated system for the Certification of Qualifications of non formal education**
- **Development and implementation of specific Qualifications Certification Schemes (VET Trainers' Certification)**
- **Quality Assurance of Lifelong learning and vocational guidance**
- **Initiation of occupational rights regarding qualifications (excluding tertiary education)**
- **Vocational Guidance services**, aiming at the authorities in charge in the Ministry of Education and the Ministry of Labor, Social Security and Welfare

Background - Milestones

- **2001:** First VET Trainers Register established
- **2007-2008:** National Training of Trainers 300 h distance learning programme implemented. Nearly 10.000 trainers attended
Nearly 8.300 trainers certified
- **2008:** First VET Trainers' Occupational Profile developed and Certified, comprising of KSC and main occupational functions
- **April 2012:** New – Updated Vet Trainers Occupational Profile delivered. Development of Curriculum Framework and VET Trainers' Certification Guide. Training of Trainers' Counselors- Mentors. Training of Trainers' assessors.
- **October 2012:** New Ministerial Decision on the Certification of Educational Adequacy of Adult Trainers of non formal education. (ΓΠ/20082/ΦΕΚ Β' 2844/23-10-2012).
- **December 2012- June 2013:** Upgrade of existing informational platform software and apps. Development of Certified Trainers' e-Portfolio
- **February 2013:** Open call of interest for the development of databank of questions – answers for the certification exams
- **March 2013:** Open call of interest for the establishment of pool of examination centers in all 13 prefectures


Main Statistics of Trainers' Register

- 8.307 Certified Trainers


Main Statistics of Trainers' Register





path 2


- Certification, following submission of e-application and participation in assessment process

Process of Certification




Expected Outcomes
